

SECRET MIND READING TECHNOLOGIES.

Few realise that US National Security laws conceal a myriad of devices that are used covertly against the civilian population. Military and civilian agencies carry out human research and black ops using all manner of mechanisms. Some 5,000 plus technologies are hidden by The Inventions Secrecy Act alone. Included in that number are powerful computer systems capable of processing over 700 trillion calculations per second each (the human mind averages only 5,000 per second) giving each machine greater capacity than 10 times the entire world's population. They also conceal satellite tracking devices that can find the proverbial needle in a haystack, indoors, in the dark as well as laser-facilitated scanning devices that can collect brain wave signals by monitoring the magnetic field around a target's head ...and all from the distance of geosynchronously orbiting satellites that number in the tens of thousands. If there are a few shocks in all of that for the reader it's because US "National Security" protection has allowed the secret development and deployment of these devices with no media revelations whatsoever. However, in the wake of the Edward Snowden mass surveillance revelations, it's hoped that further questions will now be asked about the full extent of surveillance, especially regarding "persons of interest" such as activists, writers and whistleblowers. Resolutions like the UN's resolution 68/ 167, anti spying resolution, will hopefully continue to follow the Snowden revelations but the Foreign Affairs units of the NSA and CIA constantly lobby other countries to change their own laws to legalise this sort of spying. Let's hope that the response will be more resolutions and less criminal complicity. With reference to the European Parliament resolution A4-0005/99, 28/1/99, a resolution on the environment, security and foreign policy, which called for a ban on all weapons for human manipulation, let's also hope that there are many more to follow in that vein and that they clearly focus on the horrors referred to in that resolution. In turn, those additional horrors are referred to in the history below...

The following is in the public domain. Remember that it is only a fraction of the full truth and that military researchers are always years ahead of civilian scientists...The simple truth is based on the mind as a receiver and transmitter. With today's technology it's all they really need...

1968 - Nervous System Excitation Device, US patent 3393279, Dr Patrick Flanagan, 16/7/68. This device, commonly called the Neurophone, was invented in 1959 but secrecy orders were slapped on it almost immediately. It allows audio signals to travel the nervous system as electrical impulses and register as sound in the brain; by-passing normal hearing mechanisms. Microwave tower or satellite laser delivery systems are available. The device facilitates hidden communication with agents in the field or harassment of targets to terrorise and/or discredit them. Each individual's unique bio-electronic brain resonance frequency allows for targeted input and, as you'll soon see, targeted output.

1972 - Advanced Neurophone, US patent 3647970, Dr Patrick Flanagan, 7/3/72.

1974 - Lawrence Pinneo, a neurophysiologist and electronics engineer, develops a computer system that correlates brain waves and specific commands on an ECG. This was a precursor for the mind reading technologies that followed.

1974 - Also in that year Robert Malech, of Dorn and Margolin Inc (a defense contractor), invents a radar device that can read whole brain activity from a great distance; a distant scanner. Similar technology was allegedly used illegally by neurologists doing research on patients by hiding it in walls, computer screens etc in their offices. EM oscillations from 100Mhz to 40 Ghz can be used to reach brain waves by illuminating the brain and it's electrical conductance then reading the returned signals. Again, the military and civilian spies took control of the patent and reprogrammed their surveillance and communication satellites and

immediately launched many others. The reprogramming was simple, requiring only software changes to existing radar, imaging and communication dishes and satellites. Telcos, the media and others with similar equipment benefitted and were complicit.

1976 - Apparatus and method for remotely monitoring and altering brain waves, US patent 3951134, Robert Malech, 20/4/76. This one led to the formation of the TAMI (Thought Amplifier and Mind Interface) the same year and some say that in that bicentennial year democracy itself died because of this.

1991 - Dr Edward Taub proves that the thought - activated movements of a computer cursor can actually see words communicated onto a screen.

\* 1994 - Drs Donald York (neurophysiologist) and Thomas Jensen (speech pathologist) correlate the brain wave patterns of 40 volunteer research subjects with both their words and their thoughts and create a software program with a complete brain wave vocabulary. They thus, officially, made mind reading a simple concern. Coupled with powerful satellite BW scanning equipment the thoughts of anyone and everyone are now available to the agencies with the computer capacities mentioned earlier.

1995 - Brain fingerprinting, US patent 5467777, Dr Lawrence Farwell, 21/11/95.

2000 - Communication System and method including Brain Wave analysis and/or use of brain activity, US patent 6011991, A Mardirossian, 1/4/00. This one allows word recognition, mind reading and the utilisation of neural networks...RNM (Remote Neural Monitoring) and the creation of AI.

If it's not painfully obvious from all of this let me now spell it out. The NSA, at it's Fort Meade facility and elsewhere and the CIA, at the Langley Research Centre both remotely monitor and harass ordinary citizens who've been highlighted for attention either through the mass surveillance systems mentioned by Edward Snowden or through mass brain wave scanning (looking for thoughts and thought patterns rather than topics / phrases from phone calls or emails etc). Let's make it plain that they are NOT looking for terrorists or other criminals but rather searching for those with knowledge or criticisms to offer about protected operations that powerful criminals and the agencies themselves assist with; eg black ops ...trafficking (all sorts), pedophile / fraud networks, war - mongering, false flag operations, money laundering and so on. Those targeted people are then falsely marked as needing monitoring and adjustment and are tormented with brain interference; neurophone input and mind reading..creating a remote electronic concentration camp environment.

So, rather than stopping short and merely questioning the NSA's monitoring of ALL communications we must also ask why they aren't using that vast pool of information to stop crime AND what they're doing instead to rob, ridicule and torment many, including ordinary, concerned citizens with the more advanced and classified technologies that are revealed by the technologies outlined in this article. Technologies which, after all, are merely the tip of a huge surveillance iceberg much larger and more involved than we've been allowed to realise to date.
